# The guidelines for the preparation of the joint report of the group of experts for institutions of higher education or colleges

The guidelines for the preparation of the joint report of the group of experts for institutions of higher education or colleges<sup>1</sup> (hereinafter – the experts group) (hereinafter – the guidelines) (hereinafter – HEI) are developed in accordance with Subparagraph 2.6 of Cabinet Regulation No. 407 of 14 July 2015 "Regulations on Accreditation of Higher Education Institutions, Colleges and Study Directions" and are subject to the requirements set forth in these regulations.

The purpose of the guidelines is to provide the experts group with a structured framework to prepare the joint report for the accreditation of the HEI. The experts group shall prepare the joint report in English of the accreditation of the HEI.

#### The joint report shall be prepared by the experts group:

- in accordance with the sequence set forth in the guidelines, justifying the made statements and providing references and examples;
- in accordance with the literary and grammar rules of language, legal and academic terminology;
- providing recommendations for the elimination of the deficiencies detected (in a short-term period) and for improvement of the performance of the HEI (in a long-term period).

Preparing the report, the experts group shall evaluate all assessment criteria specified in the guidelines.

Each assessment criterion is followed by aspects (in italics) which are to be taken into account when evaluating the relevant criterion. At the discretion of the experts group, it may assess other aspects which are significant for the evaluation of the relevant criterion. Evaluating each criterion, the experts group shall analyse the information available for the experts group, providing definite examples and reference to the Self-Assessment Report prepared by the HEI and information obtained during the visit.

The experts group shall analyse each criterion and make conclusions, specifying strengths and weaknesses of the HEI with regard to meeting the assessment criterion.

Preparing the joint report about the HEI, the experts group shall agree on the evaluation of the criteria and evaluate each criterion as follows: "poor", "average", "good", or "excellent". If the opinion of the experts regarding any criterion differs, the different opinion shall be specified in the joint report.

In the recommendations part, the experts group shall provide short-term recommendations for the elimination of the deficiencies detected, as well as long-term recommendations for further improvement of the performance of the HEI. In the part with the

assessment of the HEI, the experts group shall justify the recommendation about the accreditation of the HEI.

The joint report of the experts group shall be prepared in English in a computer readable form and shall be submitted in an electronic and paper format. The report submitted in a paper format shall be drawn up in duplicate and signed.

After the procedure for the accreditation of the HEI is completed, the joint report of the experts group shall be published in the Register of Study Directions.

Summary of the assessment criteria of the HEI

Evaluation	Explanation of evaluation
Poor	The HEI does not comply with the criterion to be evaluated or poorly complies with it, without a clear aim, structure and its implementation strategy. The management principles and processes are not clearly defined, implemented and known to the staff of the HEI and/or involved parties. The performance of the HEI does not meet the good practice in Latvia and in the world. The existing provision of the HEI within the specific criterion is evaluated as critical; it does not promote the quality of studies or even pose a threat to it.
Average	A regulatory framework is created in order to meet the criterion to be evaluated, but this framework is not fully implemented and the staff of the HEI and/or involved parties are not informed about it and do not take part in its implementation, provision, improvement and other stages. Though, in general, the HEI formally complies with the criterion to be evaluated, but it is not fully ensured and deficiencies in its implementation are significant and affect the study quality, while long-term planned activities, support of the interested parties and additional resources are required to eliminate them.
Good	A regulatory framework is created to meet the criterion to be evaluated; this framework is documented, implemented and the staff of the HEI and involved parties are informed about it. Regulatory framework, procedures, processes, etc. are regularly revised and improved. Methods that develop and improve the study quality are used for the implementation of the criterion. Insignificant deficiencies are detected in the HEI upon the implementation of

	the criterion to be evaluated, and these deficiencies can be easily eliminated.			
Excellent	A regulatory framework which is documented, implemented, logical and			
	effective, regularly being revised and improved is created by the HEI in			
	accordance with the criterion to be evaluated, and the staff and involved			
	parties are informed about this framework and take part in its			
	implementation. Specific methods and solutions which are adopted to the			
	study directions are used for the implementation of the criterion. These			
	methods and solutions significantly improve the study quality and can be			
	used as examples of good practice for other HEIs in Latvia and in the world.			
	Fully meeting the criterion to be evaluated, a significant contribution is			
	provided to the development of the society.

- support system for the foreign teaching staff (Is it created and implemented? / Is it effective?);
- activities of the academic staff in science, research and/or artistic creation (Is the academic staff active both nationally and internationally? / Does the academic staff successfully apply the acquired information in the study process?).

- academic integrity principles (Are they clearly defined by the HEI? / Are they being observed in all study stages? / Are all the involved parties informed about it? / Are there procedures determined in case of violation of the principles (rules)? / Are anti-plagiarism tools being applied and are they functioning and effective?);
- mechanism for ensuring the financial guarantees and options to continue studies if a study programme implemented by the HEI is cancelled or reorganized;
- if study programmes are implemented in the form of distance learning clearly defined organisation of the study process, principles of evaluation of students' achievements and support provided for students to achieve the study results (if applicable);
- if study programmes are implemented in the branches of the HEI main places of the implementation and branches' responsibilities with regard to the implementation of the study programmes are determined; cooperation is effective and ensures achieving the aims set for the study programmes (if applicable).

- mechanism of the HEI for attraction of foreign students and teaching staff (Is it created, systematic and functioning?);
- joint study programmes with foreign HEIs and study programmes in foreign languages (if applicable);
- *HEI* in the international environment (Is the HEI included in an international organisation of the relevant industry? / Does it have any international marks of quality, quality certificates etc.?).
